Message from The Governor

Greeting Sunburst Members,

Days are getting a lot shorter, temperatures have dropped and the trees are starting to show all of the autumn glory. The Midwest Region competition season comes to a screeching halt by the end of this month. There are rallies in Loves Park, IL on the 2nd, and rallies in Wentzville, MO and Delafield, WI on the 8th.

The season wraps up with a final autocross weekend at McHenry County College on October 15 & 16, hosted by Northern Illinois Corvette Club, Northern Rays, Windy City and Sunburst. Once again, we will need the help of club members to make this a safe and successful weekend. Corner workers will be needed on both Saturday and Sunday for morning and afternoon shifts. As a bonus, we will be having **FUN RUNS**, after the competition has been completed on both days. This is a great opportunity to drive the autocross course, without the pressure of being timed – **JUST FOR FUN**. Of course, if you want the thrill of trying out your competitive spirit you can race with Mike, Jim, Karen, JR and Moush. Remember Sunburst has three "loaner" helmets for use.

Pat and I attended the regional and national NCCC Governors' meetings in St. Louis on Sept 9 & 10. There were a number of proposed rule changes that were discussed for the 2024 rule book. They included:

- Increasing the number of sanctioned events from 10 to 14 for every NCCC Club.
- Prohibiting EV's (electric vehicles) from competing in speed events.
- Increasing the standards for obtaining a high speed license.
- Changing the language on event flyer to reflect rule book changes
- Changing the national recognition program to be more inclusive for car show and rally participants.

The 2020 NCCC convention organizers presented a final report and were proud to announce a \$20,000 profit for the event held in Atlantic City. The 2023 Convention will be held in Bowling Green from June 24 thru the 30th and coincide with the 70th anniversary of the Corvette. The 2024 Convention will be held in Joplin, MO.

The offices of president and treasurer are up for election in November and both are contested. Dave Heinemann, of Windy City Vettes, is running against Deb Murphy from Florida for the office of president. Dave was the NCCC president prior to Dale Samuelson's election. We wish him luck.

Finally, it looks like Mad City Vettes will be the new Midwest Region Champions for 2022. With that title comes the responsibility of hosting the annual awards banquet. Right now, it looks like the banquet will be held on March 25th in Madison, WI. Mark your calendars and wait for more details to be released in the near future.

- Saturday and Sunday are both 7 Event Days.
- o Times will be posted, but participants are encouraged to view them via their smartphones.
- Social distancing will be required in all situations.
- There is absolutely NO SMOKING OR VAPING ON MCC property.
- No alcohol or mood modifiers are allowed before, during, or after the event.
- Racers may be asked to work in order to minimize the number of participants.
- o In case of emergency Dial 911. Your location is 8900- US 14, Crystal Lake.
- \circ $\;$ Please put all waste in the trash container and police your area before leaving.
- Knocked down cones are 2 seconds. Cones must be knocked over or completely moved out of the chalked box to earn that 2 second penalty. Lay down cones count. Hitting the cones at the finish line is a DNF. 2 tires on the grass will constitute a DNF.
- Down Cone Policy:
 - If you encounter a down cone on the course STOP, HONK YOUR HORN and get the attention of a corner worker. Proceed to the finish line. You will get a re-run.
 - If you ignore the cone, you may be charged a 2 second penalty for a down cone.
- Red Flag Stop immediately and wait for directions from a corner worker.
- All pets must be kept on a leash and please clean up after them.
- Northern Illinois Corvette Club owns and operates the timing equipment. Drivers are responsible for damage to the equipment. Hit and you own it. Special thanks to Dale and Carolyn Samuelson.
- Timing and equipment trailers are off limits. Event issues will be handled by Dale Samuelson, Dan Wagner, and Mike Stevens.
- Staging Please be ready when your run group is called. Make sure to return to your same lane for the second run in each event.
- Run Order- To be described at the Driver's Meeting.
- o There will be no lunch break
- In lieu of trophies, a voucher for food the food vendor will be provided for each day of racing.
- \circ $\;$ Numbers will be assigned by Registration per assigned number list and available numbers.
- \circ $\;$ All drivers must show a valid drivers license and NCCC members must show a current NCCC card.
- Open exhausts are prohibited.
- Passengers allowed per NCCC rules, limited loaner helmets available.

National Corvette Museum Announced Annual Club Awards at 28th Anniversary Celebration

During the Ambassador Meeting at this year's National Corvette Museum 28^{th} Anniversary Celebration held September $1^{st} - 3^{rd}$, I had the pleasure of accepting Sunburst Corvette Clubs 3^{rd} Place Award for the clubs website.



To recognize the work Corvette Clubs perform to support and promote the Museum, the National Corvette Museum presents clubs that meet certain criteria awards.

There are four categories that Corvette Clubs can submit award entries for. Each year, Corvette Clubs are invited to submit their newsletters, social media, websites, and NCM parking lot banner for a judged competition. To date Sunburst Corvette Club has not participated in the parking lot banner award but we have participated in the other three categories: news letter; website; and social media.

The materials are critiqued not only on content and design, but other criteria that include: Visual (design and layout), Overall Appeal, Neatness, Legibility, Information (useful content), and National Corvette Museum promotion.

With over 300 domestic, at large, and international Corvette clubs registered with the National Corvette Museum this is quite a prestigious honor to win one of the annual club awards.

In late 2019, a social media group was formed who's membership includes myself, Patti Schulz, Jill Gray, Mike Stevens and is led by Gary Gembala. Using the National Corvette Museum





The Family Helping Family directory that is currently published is up to date but the Password has been changed for the new year.


